HEALTH AND SAFETY ORGANISATION

<u>(Part 2)</u>

1. This part of the Policy deals with the organisation, planning, implementation, operational monitoring and management review of the Policy. It also covers the development of general policy and how we train our employees (and others) to carry out our activities. An organogram has been prepared to assist in the understanding of the health and safety structure within the School, which is shown at the end of this section.

2. **Board of Governors ("The Board").** The Board has overall collective responsibility for health and safety within the School. It has a responsibility to ensure that health and safety issues are considered and addressed and that the Policy is implemented throughout the School. They will also make adequate resources available so far as is reasonably practicable, to enable legal obligations in respect of health and safety to be met. Where appropriate, advice from a Competent Person will be sought to advise the School and tasks will be delegated to suitable employees in order to assist the Board in carrying out its duties. The Board will hold the Headmaster to account in respect of the requirements set out in this policy.

3. **Headmaster**. The Headmaster will have day to day responsibility for controlling health and safety within the School. This will include ensuring there is sufficient resource deployed to meet health and safety requirements. The Headmaster will have overall responsibility for ensuring that health and safety training is deployed as required. They will ensure that accidents are suitably and appropriately investigated and recorded. They will assist the Board in directing the overall management and development of the Policy, defining the aims of the Policy and communicating the responsibilities associated with the management of health and safety within the School. The Headmaster will delegate responsibility to the Bursar to report to the Board on health and safety performance, including any audits audit, and will assist the Board in implementing changes in the Policy which the Board have approved. The Headmaster will delegate responsibility to the Bursar for responsibility for the implementation of an Emergency Plan. [Crisis Incident Plan].

4. **Bursar**. The Bursar will have day to day management responsibility for ensuring that, so far as is reasonably practicable, arrangements are in place for:

- Safety and security
- Fire safety
- Electrical safety
- Gas safety
- Water quality
- Asbestos
- Emergencies
- Staff induction

They will also act as the School Safety Co-ordinator, whose duties will include:

- advising the Headmaster on maintenance requirements
- co-ordinating advice from specialist safety advisors and producing associated action plans
- monitoring health and safety within the School and raising concerns with the Headmaster
- compliance with the Construction (Design and Management) Regulations
- chairing the School Health and Safety Committee

5. **Heads of Department**. The Heads of Department will ensure, so far as is reasonably practicable, the health and safety of those affected by activities under their control. They are

responsible for maintaining up to date risk assessments for areas under their control. Specific risk assessment requirements are:

- Science (including harmful substances and flammable materials) Head of Science
- Sports activities Head of PE
- Drama Head of Drama
- Art (including harmful substances and flammable materials) Head of Art
- Music Head of Music
- Design & Technology Head of Design & Technology
- Outdoor lessons Deputy Headmaster
- Trips and visits Educational Visits Officer
- Cleaning functions Operations Manager (Domestic)

They will also be responsible for identifying, organising (and maintaining records) of training that is relevant to their area of control.

6. **Estates Manager**. The Estates Manager will assist the Bursar with the implementation of the following:

- Building security
- Prevention of unsupervised access by pupils to potentially dangerous areas (in cooperation with others as appropriate)
- Registration and control of visitors
- Site traffic movements
- Maintenance of School vehicles
- Testing arrangements, maintenance and records, including fire, electrical, gas, equipment, water quality, asbestos
- Good standards of maintenance, including drains, gutters etc
- Control of hazardous substances for grounds maintenance activities

7. **Catering**. The Operations Manager (Domestic) will assist the Bursar with ensuring that the Kitchen, Refectory and the provision of food meets extant Food and Hygiene and Food Safety legislation.

8. **External Health and Safety Advisors**. The Bursar will arrange as appropriate for external consultants to advise on matters of health and safety within the School. Such provision may include:

- Structural surveyors are retained to give advice on the external fabric of the School.
- Engineers monitor and service the School's plant and equipment, including boilers annually.
- Gym and fitness equipment and machinery used in both design and technology and in the Maintenance department are serviced annually.
- The School has a suitable and sufficient fire risk assessment which is reviewed annually for items in the action plan and updated annually, or when significant changes are made to the interior of buildings, or new buildings are bought or added.
- In addition to the weekly fire alarm tests, the alarm system, together with all smoke detectors, emergency lighting, and extinguishers are tested annually by a qualified contractor.
- The School has a suitable and sufficient risk assessment for legionella, every two years and a water sampling and testing regime in place.
- The School maintains an asbestos register and the Estates Manager is responsible for ensuring that it is kept up-to-date and for any sampling or removal before major works takes place. They are also responsible for the maintenance of an asbestos

management plan. He is also responsible for making sure that contractors are fully briefed on areas of asbestos before starting work.

- The School's radiation protection supervisor (RPS), Head of Science is responsible for liaison with the local authority radiation protection advisor for ensuring compliance with the lonising Radiation Regulations 1999 and local rules made to comply with these regulations. The RPS is also responsible for ensuring compliance with the Radioactive Substances Act 1993 and exemption certificates granted under them.
- The School's adherence to health and safety in catering and cleaning is subject to external inspection by the Environmental Health Department. In addition, the Operations Manager (Domestic) arranges for:
 - an external professional to take swabs of all knives, chopping boards and other kitchen equipment as required and report on those findings.
 - independent hygiene and safety audit of food storage, meal preparation and food serving areas.
 - professional advice from a dietician on healthier food, menu planning and special diets as needed.
 - the professional deep cleaning of all equipment, high level cleaning of all cooking, food preparation and storage surfaces, areas as required.
 - appropriate pest control measures to be in place.
- The School has a suitable and sufficient fire risk assessment which is reviewed annually for items in the action plan and updated every three years, or when significant changes are made to the interior of buildings, or new buildings are bought or added.
- In addition to the weekly fire alarm tests, the alarm system, together with all smoke detectors, emergency lighting, extinguishers are tested annually by a qualified contractor.
- The School has a suitable and sufficient risk assessment for legionella, every two years and a termly water sampling and testing regime in place.
- The School maintains an asbestos register and the Bursar is responsible for ensuring that it is kept up-to-date and for any sampling or removal before major works takes place. They are also responsible for the maintenance of an asbestos management plan. He is also responsible for making sure that contractors are fully briefed on areas of asbestos before starting work.
- The School's radiation protection supervisor (RPS), is responsible for liaison with the radiation protection advisor of Peterborough City Council for ensuring compliance with the Ionising Radiations Regulations 2017 and local rules made to comply with these regulations. The RPS is also responsible for ensuring compliance with the Radioactive Substances Act 1993 and exemption certificates granted under them.
- The School has current electrical test certificates for all its buildings. It uses NICEIC qualified electrical engineers to inspect and maintain its electrical installations.
- All work on gas boilers and appliances is carried out by registered Gas Safe engineers.
- All domestic boilers are serviced annually, and all domestic properties have current landlord's gas safety certificates.
- All lightning protection and earthing conforms to BS 6651-1999 or to BS EN 62305. It is tested annually by a specialist contractor.
- A competent Principal Designer, Principal Contractor / Contractor is appointed in order to ensure compliance with the Construction (Design and Management) (CDM) Regulations 2015 whenever construction work is undertaken.

9. **School Health and Safety Committee**. The Committee will meet once a term (routinely on the start of term Inset day) and will be chaired by the Bursar. The Governor who is responsible for overseeing health and safety will attend these meetings. The other members of the Committee will be:

The role of the Committee is to:

- discuss matters concerning health and safety, including any changes to regulations;
- monitor the effectiveness of health and safety within the School;
- review accidents and near misses, and discuss preventative measures;
- review and update risk assessments;
- discuss training requirements;
- monitor the implementation of professional advice;
- review the safety policy guidance and updating it;
- assist in the development of safety rules and safe systems of work;
- monitor communication and publicity relating to health and safety in the workplace;
- encourage suggestions and reporting of defects by all members of staff.
- 10. **School Nurse**. The School Nurse will be responsible for:
 - Informing the Bursar of all accidents, incidents and near-misses, in a manner to maintain the Accident Record book and allow reporting of notifiable accidents to the Health & Safety Executive
 - Maintaining the First Aiders register, training and refresher training
 - Keeping statistics and preparing summary reports for the School Health and Safety Committee
 - Escorting pupils to hospital (and informing their parents)
 - Checking that all first aid boxes and eye wash stations are replenished and in-date

11. Staff. The co-operation of all staff in ensuring adherence to health and safety is essential to the success of the Policy. All staff are to notify their Head of Department of any hazards to health and safety which they notice and of any suggestion they wish to make regarding health and safety. Staff are required to:

- follow the Policy
- take reasonable care for the health and safety of themselves and others who may be affected
- follow requirements imposed on the School or any other person under health and safety law and co-operate fully so as to enable the duties upon them to be performed
- carry out all reasonable instructions given by managers / senior staff
- make proper use of anything provided in the interests of their health and safety such as protective equipment. Reckless or intentional interference with such equipment will potentially be regarded as a dismissible offence
- comply with any reasonable request made by any of the persons named above in relation to the fulfilment of their duties.
